



**MEMORANDUM OF AGREEMENT
BETWEEN
HASANUDDIN UNIVERSITY
AND
CHINA MEDICAL UNIVERSITY**



This agreement is intended to provide a mechanism for collaborative activities in higher education between **Hasanuddin University, Makassar, Indonesia** and **China Medical University Hospital, Taiwan**.

Subject to approval by the appropriate university authorities, represented by Dean **Muhammad Ruslin of Hasanuddin University** and **Chung-Ming Liu of Biomedical Technology R&D Center, China Medical University Hospital**, both parties agree to enter into a collaborative relationship for the benefit of their respective communities.

Both parties agree upon the following:

1. To collaborate in the field of health scientific research, education, services, cultural exchange and practical and practical training.
2. To exchange faculty and students for short- or long-term research and educational purposes.
3. To foster collaborative projects between faculties and students of both parties
4. To share information about research, education resources and programs
5. To organize symposia, conference, short courses and meetings on research issues.
6. To promote the dual-degree programs
7. To publish in journal for both parties

Faculty from each party may undertake short- or long-term exchange for collaboration in research, education, and health services. Appointments, titles and qualifications will be agreed upon in advance, after due consultation.

Students and fellows from both parties may admitted for matriculation toward advanced degrees, and students may also be welcomed for exchanges | non-degree but accredited programs. Qualifications, requirements and limitations will be agreed upon in advance, and students will be selected through due procedure by both parties.

COSTS

Both parties agree on the following:

1. In the case of cooperative projects, cost will be discussed by both parties
2. In the case of exchange of faculty or students, the applied university or persons should be responsible for the cost

INSURANCE

Faculty members and exchange students will be required to buy overseas insurance before departure as mandated by the regulations of the host institution and/or country.

LIABILITY

Faculty and students shall abide by policies of both the host and sending universities regarding liability insurance, which will cover expenses for emergency medical care, hospitalization and repatriation for trips overseas, as well as worker's compensation coverage where applicable.

The agreement for cooperation will become effective for a period of five years upon the date of signature by the representatives of the two universities. The agreement may be amended or revised at any time by the mutual, written consent of the parties. It may be terminated by either party by providing six months' notice to the other of its intention to terminate.


